ORDER

Sanction was accorded as per B.O read 1st above for the revised cost estimate for the balance E&M works of Pallivasal Extension Scheme and the Chief Engineer (Gen.& PED) was authorized to invite tender with modified commercial and PQ conditions on reverse bidding basis.

Accordingly, M/s. Metal Scrap Trade Corporation Ltd. (M/s. MSTC) who is offering reverse bidding platforms was contacted and an Agreement was executed by the Chief Engineer (Gen.&PED) for reverse bidding of the subject work. It is reported that on subsequent communications with M/s. MSTC, it is known that the facility offered by them includes the option of reverse auction also. In case of reverse auction, the L1 bidder found out during reverse bidding process need not be L1 after reverse auction and any bidder can become L1. Considering the exigency of tendering the works, the Chief Engineer (Gen.& PED) has floated the tender as per e-Tender No. CEPED/06/2020-21 dated 10-07-2020 on reverse bidding basis with facility for reverse auction, for discovering the lowest price for the Bid and requested ratification for the same.

Having considered the matter, as per the Note read as 3rd above, the Full Time Directors in the meeting held on 22-07-2020, resolved to ratify the action of the Chief Engineer (Gen. & PED) in having included the provision for reverse auction subsequent to reverse bidding in the tender for balance E&M works of Pallivasal Extension Scheme (2x30MW).

Orders are issued accordingly.
