ORDER

As per the B.O. read as 1st above, sanction was accorded for the formation of 30 new Electrical Sections including Electrical Section at Kayaradi. The Deputy Chief Engineer of Electrical Circles concerned was entrusted to explore the possibility of obtaining suitable building free of rent or minimum 10 cents of land free of cost for constructing the building to accommodate the new offices and to make alternate arrangements till the above materialize by requesting the authorities of local bodies in the respective area to provide rent free accommodation for the newly formed Electrical Sections. Also it was directed that the new sections be made functional as and when the land is made available as above or the rent free accommodation is provided.

As per the letter read as 2nd above, the Deputy Chief Engineer, Electrical Circle, Palakkad reported that the President, Ayilur Grama Panchayat had informed that the Grama Panchayat had passed a resolution allocating two buildings under the ownership of the Panchayat at Karinkulam for the functioning of the newly formed Electrical Section, Kayaradi. The Panchayat had requested necessary actions for the commencement of the Section Office in the allotted building.

In the circumstances, the Deputy Chief Engineer, Electrical Circle, Palakkad requested necessary action for starting the functioning of Electrical Section, Kayaradi.

The Executive Engineer, Electrical Division, Alathur as per letter read as 3rd above had forwarded a copy of the resolution dated 13/12/2019 of the Ayilur Grama Panchayat allocating the buildings of old Thiruvazhiyad Village Office and the VEO quarters at Karinkulam at free of

It is reported that the two buildings allotted are having a total area of 1,800 sqft. The first building is two storeyed with three rooms in the ground floor having an area of 650 sqft. The hall in the first floor is having an area of 650 sqft is covered with sheet roof. The second building with sheet roof is attached to the first building and is having an area of 500 sqft. The buildings are spacious and have enough facilities for the functioning of the Section office.

The Deputy Chief Engineer, Electrical Circle, Palakkad has reported that the Panchayat authorities are doing the modification works for handing over the building to KSEB Ltd.

The matter was placed before the Full Time Directors as per note read as 4th above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 14/07/2020, resolved to accord sanction for commencing the functioning of newly formed Electrical Section, Kayaradi by suitable deployment of staff in the rent free buildings of old Thiruvazhiyad Village Office and the VEO quarters at Karinkulam offered by the Ayilur Grama Panchayat.

Orders are issued accordingly.
