Procurement of 200 MW Solar power through tariff based competitive bidding on All India basis -- remarks submitted to KSERC on the observation of the Hon'ble Commission on the bidding documents submitted by KSEBL – Ratified orders issued.

#### **ORDER**

As per Board order read as 1<sup>st</sup> above, sanction has been accorded to seek the approval of Hon'ble KSERC for the deviation from the guidelines of MNRE in the bid documents (RfS and PPA) prepared for the procurement of 200 MW solar power from grid connected Solar PV plants through competitive bidding on All India basis. Accordingly, the modified bid documents (RFS and PPA) are submitted to the KSERC for approval for the deviations from the standard guidelines and the amended guidelines of MNRE dated 22<sup>nd</sup> Oct 2019.

The KSERC had forwarded the 'Observation and Comments on the bidding documents submitted by KSEBL' and had conducted hearing on the petition through Video Conference on 09.06.2020. Based on the hearing and observations forwarded by KSERC, it was directed to modify the bid documents and resubmit the petition by 22<sup>nd</sup> June 2020. The remarks of KSEBL on the observations (44 nos) forwarded by KSERC has been prepared in detail.

The Deputy Chief Engineer (Commercial and Planning) with full powers of Chief Engineer as per the note read as 3<sup>rd</sup> above has reported that considering the urgency that the petition has to be submitted before KSERC on 22.06.2020, the Chairman and Managing Director KSEBL in the note read as 2<sup>nd</sup> above had directed to submit the remarks prepared by KSEBL before KSERC and put up the note for ratification. Accordingly the remarks prepared by KSEBL have been submitted to KSERC on

22.06.2020 by the Deputy Chief Engineer (Commercial & Planning) with full powers of Chief Engineer.

Having considered the matter in detail, the Full Time Directors in its meeting held on 25.06.2020, resolved to ratify the action of the Deputy Chief Engineer (Commercial & Planning) with full powers of Chief Engineer in having submitted the remarks (attached as **Annexure**) on the 'observations and comments' of KSERC on the bidding documents for procurement of 200 MW Solar power on All India basis to KSERC within the time limit in anticipation of sanction.


