ORDER

The Government of Kerala has issued specific instructions for preventing the spread of pandemic, Novel Corona virus (COVID-19) in the State and precautionary measures to be taken in all Government offices. KSEB Ltd is also taking all possible steps to prevent the spread of the pandemic in KSEBL offices. As part of efforts to contain the disease and to ensure the safety of employees, it has been decided as per circular read as 1st above to provide Infrared Thermometers in KSEBL offices by purchasing the item from Kerala Medical Services Corporation Ltd (KMSCL), which is a Kerala Government owned company and the Executive Engineer, Civil Division, Thiruvananthapuram has been entrusted with the purchase after getting requirement from all offices.

Accordingly various ARU's have furnished their requirements and as per these, a total of 1500 numbers of Infrared Thermometers are required to be purchased for issuing to the required offices. The KMSCL as per proforma invoice read as 2nd above has furnished the rate and total cost of purchase. As per their offer the cost of one Infrared Thermometer is ₹2690/- including 18% GST. In addition to this 5% of the total cost is payable towards handling /delivery charges. The details of their offer are as furnished below:

To ensure the smooth distribution of thermo scanners in field offices, it is suggested to entrust the Deputy Chief Engineers of Electrical Circles situated at District Head Quarters with the responsibility of arranging the distribution of the items to the respective offices under Distribution, Transmission and Generation wings situated within their districts, as per the list furnished from the Civil Division, Thiruvananthapuram. M/s KMSCL have agreed to supply the items at KSEBL Electrical Circle offices situated in all districts. The payment towards the purchase can be made from the office of the Chief Engineer (HRM) after getting confirmation of receipt of the items from concerned Electrical Circles.

In view of the above and considering the urgency of purchasing the item in the wake of increasing number of COVID-19 pandemic cases in the State, the Chief Engineer(Civil Construction) South has recommended the request made by the Executive Engineer, Civil Division, Thiruvananthapuram for authorising the Executive Engineer, Civil Division, Thiruvananthapuram to purchase 1500 Nos Non-contact Infrared Thermometers from the Kerala Medical Services Corporation Limited at a total cost of ₹42,36,750/- (Rupees forty two lakh thirty six thousand seven hundred and fifty only) including 18% GST and 5% handling charges, by waiving the tender procedure.

Having considered the matter in detail as per note read as 5th above, the Full Time Directors of KSEBL, in the meeting held on 08.07.2020, Resolved to accord sanction to the Executive Engineer, Civil Division, Thiruvananthapuram to purchase 1500 Nos. of Non-contact Infrared Thermometers from Kerala Medical Services Corporation Limited at a total cost of ₹42,36,750/- (Rupees forty two lakh thirty six thousand seven hundred and fifty only) including 18% GST and 5% handling charges, by waiving the tender procedure.

Resolved further to authorise the Deputy Chief Engineers of Electrical Circles, situated at District Head Quarters, to make arrangements to distribute the Infrared Thermometers to the offices under Distribution, Transmission and Generation wings situated within their district as per the details furnished from Civil Division, Thiruvananthapuram and to intimate the confirmation of receipt to Civil Division, Thiruvananthapuram for arranging payment.

Resolved also to authorize the Financial Advisor, KSEBL for necessary budget allocation for the purchase as above and to entrust the Chief Engineer (HRM) to effect the payment to M/s KMSCL after satisfactory supply of the items.

Orders are issued accordingly.
