ABSTRACT

Construction of 220/110kV GIS Substation at Irinjalakuda- purchase of land by negotiation through DLPC - sanctioned- orders issued.

ORDER

The Administrative Sanction was accorded as per B.O. read as 1st above for the construction of 220kV/110kV GIS Substation, Irinjalakuda and its associated lines for an estimate amounting to Rs. 236.58 Crores. In the estimate, an amount of Rs. 6.67 Crore was provided for the purchase of land to be met from the KIIFB fund for TransGrid Projects.

The Chief Engineer, TransGrid has reported as per note read as 2nd above that the land to an extent of 202 cent in Manavalassery Village, Mukundapuram Taluk in Thrissur District owned by Adv. K.S. Bharathan, H No. 29, 'Amoolya', Anjumana Road, Mamangalam, Edappally in Survey No. 768/1, 768/2 & 769/1, located within 500m from the existing 110kV Substation at Irinjalakkuda, is found suitable for the proposed 220 kV Gas Insulated Substation construction. The proposed land is plain, hence GIS construction can be undertaken without any major site filling and leveling works.

The matter was placed before the Full Time Directors as per note read as 3rd above. Having considered the matter in detail, the Full Time Directors in the meeting held on 18.06.2020,

Resolved to accord sanction for the purchase of 202 cents of land in survey No. 768/1, 768/2 & 769/1 of Manavalassery Village, Mukundapuram Taluk, Thrissur District belonging to Adv. K.S. Bharathan, H. No. 29, 'Amoolya', Anjumana Road, Mamangalam, Edappally through negotiated purchase by the District Level Purchase Committee (DLPC) for the construction of 220/110kV GIS Substation at Irinjalakuda.
