New HT service connection given to KWA Raw Water Pump House Kanjar under Electrical Section, Moolamattom with arrears outstanding- ratification – Sanctioned – Orders issued

### **ORDER**

Application for a new HT Service connection for Kerala Water Authority, Raw Water Pump House, Kanjar under Electrical Section, Moolamattom, with a contract demand of 220kVA, was received from the Assistant Executive Engineer II, Kerala Water Authority, Project Sub Division, Thodupuzha. This project is an extension of the existing LT connection having a connected load of 83.89 kW and on commissioning of this new HT connection, the LT connection needs to be dismantled. The arrears for the existing LT connection, upto February 2020 w.e.f from 01.10.2018 amounts to Rs. 74,02,572(Principal Rs.66,70,676 + Surcharge Rs.7,31,896).

The Kerala Water Authority was intimated to clear the arrears outstanding against the above connection for obtaining new Service connection. The Assistant Executive Engineer II, Kerala Water Authority, in this regard, requested to effect the new HT connection by adjusting the arrears and Security Deposit from the amount (Rs. 30,50,22,659) already remitted by KWA on 28.11.2019 at KSEB HQ against power charges. Accordingly, the matter was taken up with the Finance Adviser of KSEBL to ascertain the admissibility of the request of KWA to adjust the arrear against the said LT connection from the payment made by KWA.

The Financial Adviser, KSEBL, based on the report from the Special Officer (Revenue), KSEBL, informed that the above amount remitted by Kerala Water Authority has already been adjusted against the current charges of 263 HT consumers of KWA. Hence, it is not possible to adjust the arrear amount against this LT consumer. Accordingly, the Assistant Executive Engineer

II of Kerala Water Authority was informed to remit the arrear amount for getting the new III service connection.

Considering the urgency in getting connection and considering that it is a Government department, the Deputy Chief Engineer, Electrical Circle, Thodupuzha requested the Assistant Executive Engineer, KWA to remit the security deposit amount of Rs. 6,41,450/- for the new connection without insisting on remittance of current charge arrears. The said amount was remitted by KWA on 13.03.2020 and the service connection was effected on 18.03.2020.

The Deputy Chief Engineer, Electrical Circle, Thodupuzha, as per letter read 1 above, has requested to ratify his action in having permitted the Kerala Water Authority to remit the Security Deposit for the new connection without clearing the arrears.

The matter was placed before the Full Time Directors as per note read as 3<sup>rd</sup> above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 30.04.2020, resolved to ratify the action of the Deputy Chief Engineer, Electrical Circle, Thodupuzha in having released the HT connection to Raw Water Pump House, Kanjar under Electrical Section, Moolamattom without clearing the current charge arrears of LT service connection.

Further resolved to direct the Deputy Chief Engineer, Electrical Circle, Thodupuzha to inform the Kerala Water Authority to clear the balance arrear amount at the earliest.

Orders are issued accordingly.
