## **ORDER**

The Government of Kerala as per order read as 1<sup>st</sup> above have directed KSEBL to adopt the Office Memorandum read as 2<sup>nd</sup> above in all procurements of all items specified in view of 'Make in India' policy. It was also stated that the same is required to support the Indian Industry in the post COVID situation and deviation, if any required for adopting the order may be referred to MNRE, Government of India, through the State Government.

As per the Office Memorandum, the Public Procurement Order 2017 (Preference to Make in India) is applicable to all Ministries/ Departments attached or subordinate officers of the Government of India or Autonomous bodies controlled by the Govt of India and include Government companies as defined under the Companies Act 2013 and they shall follow the above orders in all their procurements.

The electricity generated from the projects through renewable energy products procured under this Public Procurement order (Preference to Make in India) shall be utilised for captive / non-commercial purposes only. Also it is mentioned that for grid connected solar power projects, Solar Modules - 100 % shall be domestically

manufactured and other components such as inverters etc - 40 % shall be domestically manufactured.

The State Nodal Officer, Soura Project as per note read as 3<sup>rd</sup> above, suggested to adopt the G O read above by KSEB Ltd/ PSUs in all renewable energy plants constructed for its own/captive purpose.

Having considered the matter in detail, the Full Time Directors in the meeting held on 25.6.2020, resolved to adopt the GO (Rt) No.65/2020/POWER dated Thiruvananthapuram, 23/05/2020 in KSEBL in all its renewable energy projects for captive/non-commercial purpose.

Orders are issued accordingly.
