### ORDER

The Government of Kerala as per order read as 1<sup>st</sup> above had approved a comprehensive Rehabilitation and Resettlement Policy and package for land acquisition in the state and the same was adopted in KSE Board as per Board order read as 2<sup>nd</sup> above.

Further the Board as per order read as 3<sup>rd</sup> above had accorded sanction to rehabilitate the 77 families whose land and building will be acquired for the implementation of the project, who will become landless and homeless by the implementation of Mankulam HEP, with no salaried income and whose annual income is below Rs.75000/-, by providing 3 cents of land each (77x3=231cent). The above facility shall be provided only to families whose family income is below Rs.75000/annum. It was also ordered that the possibility of rehabilitation in project land available with KSEB in Idukki district shall be explored and only if it is not feasible, fresh land acquisition shall be attempted to rehabilitate the above 77 families. Accordingly an extent of 1.555 Ha of non-patta Board's land in Sy. No. 229 in Block No. 10 Kunchithanni village, Devikulam Taluk adjacent to Sengulam dam at Anachal in Idukki district was identified for the rehabilitation of the affected persons. Subsequently KSEBL had accorded sanction to provide 3 cents of land to 20 beneficiaries .

Now Chief Engineer (Civil- Investigation & Construction Central) as per note read as 4<sup>th</sup> above has reported that the following 9 landholders who have already handed over their land and residential building to KSEBL for the implementation of the project are eligible to get 3 cent of land each as compensation.

The proposal was placed before the Full Time Directors as per note read as 5<sup>th</sup> above. Having considered the matter in detail, the Full Time Directors in its meeting held on, 25.06.2020 resolved to accord sanction to provide 3 cents of KSEBL's land each in Survey No.229 in Block No.10, in Kunchithanni Village, Devikulam Taluk of Idukki District to following 9 land holders who have already handed over their land and residential building for the implementation of Mankulam HE project and are eligible to get 3 cents of land as compensation with no salaried income and whose annual income is below Rs.75,000/-.


