ORDER

Sri Ramachandran P, Overseer (Emp Code 1050786) was sanctioned Special Disability Leave (SDL) for 119 days from 05.01.2017 to 03.05.2017 as per proceedings read 1st above with the condition that, the leave already sanctioned, excluding earned leave if any, may be cancelled and half monthly compensation paid, if any, may be adjusted from the leave salary admissible. In the mean time, the field office sanctioned eligible leave including Earned leave for 42 days for preferring salary for the requested period. The incumbent, aggrieved by the loss of 42 Earned Leave consequent to sanction of SDL requested as per the submission above read 1st above for conversion of Earned Leave to SDL. The incumbent pointed out that similarly placed employee Sri Jayan T K, Overseer, 110 KV Substation, Pathripala was allowed to convert EL to SDL by the FTD meeting held on 25.07.2018 by setting aside the provisions of Rule 76 Part I of KSR as a special case.

The matter was placed before the Chairman & Managing Director, KSEBL as per note read 4th as above and the Chairman & Managing Director directed to place the matter before the Full Time Directors of KSEBL for consideration. Accordingly the matter was placed before the FTD meeting as per note read as 5th above.

The Full Time Directors in its meeting held on 11.06.2020 resolved to accord sanction to convert the Earned Leave into Special Disability Leave, availed by Sri Ramachandran P, Overseer during the period of treatment consequent to accident occurred during the

course of employment, by setting aside Rule 76 of Part 1 of KSR as a special case, considering the fact that the employee has later underwent liver transplantation and is facing financial issues.
