ORDER

The Chief Engineer (IT,CR & CAPs) as per note read as 3rd above has reported that KSEBL as per order read (1) above accorded sanction to carry out the Security Deposit(SD) reassessment, refund of excess SD and collection of Additional Security Deposit during the 2nd quarter of the financial year 2020-21 (July, August, September) instead of first quarter of financial year 2020-21 considering the pandemic COVID-19. It is also reported that industrial and commercial consumers are facing difficulty in payment of fixed charges due to lock-down and domestic consumers are facing difficulty due to their increased consumption during the lock down period.

In view of the these circumstances and to alleviate the hardships of consumers, the Chief Engineer(IT,CR & CAPs) recommended to exempt the issue of ACD notice for collection of Additional Security Deposit during this financial year (2020-21). It is also suggested to carryout the SD reassessment and refund of excess SD (if any) for all LT/HT/EHT consumers during the 2nd quarter of financial year 2020-21. The Chief Engineer(IT,CR & CAPs) further recommended to authorize the Deputy Chief Engineer with full powers of Chief Engineer(Commercial & Planning) to obtain necessary approval from KSERC for the above.

Having considered the matter in detail, the Full Time Directors in its meeting held on 18.06.2020 resolved to accord sanction for the following

1. To exempt the generation of ACD demand and issuing ACD notice for collection of Additional Security Deposit during the financial year 2020-21.
2. To carryout the SD reassessment and to refund excess SD (if any) for all LT/HT/EHT consumers during the 2nd quarter of financial year 2020-21
3. To authorize the Deputy Chief Engineer with full powers of Chief Engineer(Commercial & Planning) to obtain necessary approval from KSERC for the above.

Orders are issued accordingly.


