ORDER

The Chief Engineer (IT,CR & CAPS) as per note read as 5th above has reported that M/s.Bharti Airtel Ltd and M/s BSNL was selected as the Primary network bandwidth service provider (BWSP) and secondary service provider respectively for RAPDRP and Non-RAPDRP Project in KSEB Ltd for establishing MPLS/VPN connectivity as per the LOA read as 1st and 2nd above . The Addendums to the orginal LOA were also issued based on the new offices added to this project. The contract period of the initial orders were for 5 years, and expired for M/s Airtel on 17.07.2018 and for M/s BSNL on 02.08.2018. Further extension was given for the period of three years to the initial orders . Now the contract period for the Addendums read as 3rd and 4th above of M/s Airtel (89 links) and M/s BSNL(82 links) for additional quantity of 512 kbps MPLS/VPN links under Non RAPDRP got expired on 15.05.2020.

KSEB Ltd has to continue the utilization of the links established since the services and applications implemented under RAPDRP and Non-RAPDRP Projects and KSEBL business applications are being used across various offices and considering the technical challenges and disruptions in the existing WAN in engaging a BWSP other than M/s. Airtel or M/s. BSNL, Offer has been collected from M/s Airtel and M/s BSNL above for continuing the connectivity services already established as per addendum for a further period of 3 years from their respective contract expiry dates with the currently existing contract and Service Level Agreement (SLA) terms & conditions of extension order.

M/s. Airtel and M/s BSNL agreed to continue the services at the rates(excluding taxes)

In view of the above, the Chief Engineer(IT,CR & CAPs) suggested to continue the connectivity services already established with M/s. Airtel(89 links) and M/s. BSNL (82 links) vide Addendums read as 3rd and 4th above for a further period of 3 years from their respective contract expiry dates with the rates as in Table with the Service Level Agreement (SLA) terms & conditions of the existing contract.

Having considered the matter in detail the Full Time Directors in its meeting held on 11.06.2020, resolved to accord sanction to continue the connectivity services already established with M/s. Airtel for 89 number of links and M/s. BSNL for 82 number of links vide Addendums dated 16.05.2015 for a further period of 3 years from their respective contract expiry dates with the rates as in Table with the Service Level Agreement (SLA) terms & conditions of the existing contract.


