Decommissioning of PPRA-VELI-TERLS 66kV Line from Locations 36 to 38 and 66kV Tower at Location 37 under Transmission Circle, Thiruvananthapuram – Sanction accorded – Orders issued.

ORDER

The Chief Engineer (Trans. South) as per note read as 1st above has reported that M/s.VSSC requested for dismantling the 66kV PPRA – VELI – TERLS line passing through their compound from locations 36 to 38 and also the 66kV tower at location 37 in the line route.

The 66kV Substation, Veli was upgraded to 110kV level and a new line was constructed from the 110kV Substation, TERLS to the Substation, VELI. It has been informed that the 66kV PPRA-VELI-TERLS line from locations 28 to 38 was de-energised after the construction of the said 110kV line from TERLS Substation to Veli Substation.

The Chief Engineer (Trans. South) as per note cited 2nd above has intimated that M/s.VSSC requires dismantling of the line from locations 36 to 38 and is also willing to bear all the dismantling charges towards dismantling the line as well as the tower from their compound (from locations 36 to 38). The locations 37 & 38 are in the premises of VSSC and as the 66kV tower at location 37 is also requested to be dismantled, the line between locations 36 and 37 is also to be dismantled.

In view of the above, the Chief Engineer (Trans. South) as per note read as 1st above, requested sanction for the decommissioning of the 66kV line passing through the compound of M/s.VSSC on Deposit Work basis.

The matter was placed before the Full Time Directors as per note read as 3rd above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 11.06.2020,
Resolved to accord sanction to the Chief Engineer (Transmission-South) for the decommissioning of
the 66kV PPRA-VELI-TERLS line from locations 36 to 38 passing through the compound of M/s.
VSSC on Deposit Work basis.

Orders are issued accordingly.


