**ORDER**

The Government ITI, Chengannur is a deemed HT consumer( HTB 24/3700) under Electrical Section, Chengannur availing LT connection and billing being done from the Special Officer (Revenue), Thiruvananthapuram. The consumer submitted application and connected papers for converting to HT connection for which the power feasibility was issued and the system development work was completed at their cost. The Deputy Chief Engineer, Electrical Circle, Harippad requested the consumer to remit the pending arrears due to them. The Principal, Government ITI, Chengannur, in reply intimated, that the bills for clearing the present current charge arrears have already been submitted to the Treasury and clearing of previous dues may be considered under OTS and also requested to proceed with the execution of HT agreement.

The Chief Engineer Distribution (Central), as per letter read 1<sup>st</sup> above sought necessary direction/ clarification whether to proceed with the execution of HT agreement with the consumer, who has pending arrears.

The Special Officer (Revenue), in the remarks read as 2<sup>nd</sup> above, intimated that the said consumer has a long pending arrear for the period from 12/1989 to 2/1990 for Rs.23,525/- plus interest. As per the request of the consumer One Time Settlement Scheme 2019 was sanctioned, as per Board Order read as 3<sup>rd</sup> above. But the consumer has not availed the One Time Settlement benefit. In addition to the aforesaid 23,525/-, current charge with effect from 01/2020 was also due from this consumer. Thus the total amount outstanding from Government ITI, Chengannur as on 08.05.2020 comes to Rs.1,84,245/- plus interest.

The Director (Finance), in the Note read as 4<sup>th</sup> above directed to place the matter before the Full Time Directors.

Accordingly, the matter was placed before Full Time Directors as per note read as 5<sup>th</sup> above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 18.06.2020, resolved to accord sanction to the Deputy Chief Engineer, Electrical Circle, Harippad to proceed with the execution of HT agreement with the consumer, after obtaining an undertaking to remit the balance amount at the earliest, considering the fact that the consumer is a Government institution.

Orders are issued accordingly.


