### ORDER

M/s.Little Flower Hospital, Angamaly, had registered for the grid connectivity of their 500kWp solar power plant on 27.04.2019 and the completion period of the plant was once extended upto 26.04.2020 as per their request on 14.10.2019. Now, Father Sebastian Kalappurackal, Director, Little Flower Hospital, Angamaly, has requested to extend the completion period upto December 2020, as the work delayed due to the present situation of Covid 19 and lockdown.

As per Clause 13(9) of KSERC Regulation read as 1<sup>st</sup> above, the registration shall be valid only for a period of six months from the date of registration. Further, as per Clause 9(c) of KSERC Regulation read as 2<sup>nd</sup> above, the distribution licensee can extend the validity of registration for a period not exceeding six months, if sufficient reasons are there beyond the control of the applicant.

The Chief Engineer (Renewable Energy & Energy Savings), in the Note read as 5<sup>th</sup> above, has informed that in the previous similar cases of registration expiry, KSERC in the Order read as 3<sup>rd</sup> above, had provided connectivity to 50kWp plant installed by M/s.Kerala State Industries Enterprises Ltd (KSIE) by accepting original registration fee (Rs.50,000/-) without insisting re-registration and to refund the registration fee (Rs.50,000/-) to M/s.Amal Jyothi College of Engineering (AJCE), Kanjirapally, which they have made after expiry of validity of registration. The Hon'ble Commission had observed that the applicants are not frivolous and the opportunities of other consumers are not blocked in these cases.

KSEBL had adopted the same principle and directed, as per the Orders read as 4<sup>th</sup> above, not to collect registration fee again, from thirteen other consumers; which has been taken up with KSERC for ratification.

The Chief Engineer (Renewable Energy & Energy Savings), in the Note read as 5<sup>th</sup> above, has further recommended the extension of connectivity of this 500kWp plant in 11kV KSRTC feeder, as no other solar addition in this feeder so far.

Having considered the matter in detail, the Full Time Directors in the meeting held on 14.06.2020 :

- Resolved to accord sanction to extend the completion period of 500kWp plant at M/s.Little Flower Hospital, Angamaly, for a further period, ie, upto December 2020 (31.12.2020).
- Further resolved to accord sanction to direct the Deputy Chief Engineer (Commercial & Planning) with full Powers of Chief Engineer, to take up the matter with KSERC for ratification.

Orders are issued accordingly.


