ORDER

The Chief Engineer(Civil -Dam Safety & DRIP) as per note read as 1st above has reported that the field divisions manning the dams of KSEBL are the backbone of the Dam Safety wing and it is very essential that these offices are to be equipped to stay in tandem with the top management of KSEBL in various decision making process concerned with reservoir management as well as dam safety. During heavy rain, dam and reservoir monitoring is very important and indispensable for ensuring the safety of the life and property of the stakeholders downstream of dams. So these officers are to be equipped and adaptive with various tools used in the decision support system and decision making process.

In order to achieve the above objective, the Chairman and Managing Director in the meeting held on 26.5.2020 to review the monsoon preparedness, instructed to procure laptops to all the Executive Engineers of the Dam Safety field divisions so that they can receive, compile disseminate and furnish timely information to the decision makers at various levels of administration in KSEBL as well as the State as the case may be.

Accordingly the Chief Engineer (Civil -Dam Safety & DRIP) has forwarded a proposal for procuring 5 laptops one each to the Executive Engineers of Dam Safety field divisions and requested sanction to procure it through limited quotation without EMD. Laptop with Intel Core i7 processor is proposed to the Executive Engineer, Dam Safety Division, Vazhathope for using free Simulation softwares like HEC-ResSim, HEC-RAS etc. for analysing reservoir operations and Intel Core i5 for others. The details are as shown below:

Having considered the matter in detail, the Full Time Directors in the meeting held on 11.06.2020 resolved to accord sanction to the Chief Engineer(Civil -Dam Safety & DRIP) to procure 5 laptops for the use of Executive Engineers of Dam Safety Divisions of Vazhathope, Kakkad, Pambla, Idamalayar & Thariode, within a financial commitment of Rs.3,60,000/-, (Rupees Three lakh and Sixty thousand only) through limited quotations by waiving EMD.

Further resolved to direct the Financial Adviser to allocate special credit for releasing the amount against the procurement so as to effect payment within 7 days of successful installation.

The Chief Engineer (Civil-Dam Safety&DRIP) shall take further necessary action.
