#### ORDER

The Executive Engineer, Electrical Division, Thiruvananthapuram as per letter read as 1<sup>st</sup> above reported that an application dated 29.02.2020 from Sri.G.Satheesh Kumar, Thiruvonam, TC 37/2573-1, Kodunganoor had been received for line shifting under Electrical Section, Vattiyoorkavu. The applicant is a cancer patient and BPL ration card holder. The work involves line shifting with pole insertion and estimated cost is ₹9860/-. It is also reported that the applicant had submitted application after the Vydyuthi Adalath and hence could not be included in the same. The Executive Engineer has reported that this is a deserving case and requests whether concession in line with that provided during the Vyduthi Adalath 2020 could be sanctioned to Sri.G.Satheesh Kumar.

The matter was placed before the Full Time Directors as per note read as 3rd above.

Having examined the matter in detail, the Full Time Directors in its meeting held on 11.06.2020 resolved to accord sanction to the Deputy Chief Engineer, Electrical Circle, Thiruvananthapuram to shift the electric line passing through the property of Sri.G.Satheesh Kumar under Electrical Section, Vattiyoorkavu using KSEBL fund as a special case, on humanitarian grounds.
