ORDER

Sri.Muhammed Nizar as per letter read as 2nd above, has submitted a petition before the Hon'ble Minister for Electricity ,requesting for installment facility to remit the estimate amount for the work for providing supply of electricity to start an Ice Plant at Kizhayur Nambram area, Pattambi stating that he cannot remit the amount in lump sum.

The Executive Engineer, Electrical Division, Pattambi, as per letter read as 1st above has accorded Administrative Sanction for an estimate amount of Rs.12,25,512/- (Twelve Lakhs Twenty Five Thousand Five Hundred and Twelve Only) on 07.04.2020, for the work of construction of HT line and installing 100kVA transformer for providing supply of electricity in favor of Sri. Muhammed Nizar, under Electrical Section Pattambi.

The Hon'ble Minister for Electricity has directed to examine whether installments can be allowed as a help to start a new enterprise and considering the present crisis, and to take appropriate action.

The matter was placed before the Full Time Directors for a decision as per Note read as 3rd above.

Having considered the matter in detail, the Full Time Directors in its meeting held on 11/06/2020,

Resolved to accord sanction to the Deputy Chief Engineer, Electrical Circle, Shoranur, to allow Sri. Muhammed Nizar to remit the estimated cost of Rs.12,25,512/- (Rupees Twelve Lakhs Twenty Five Thousand Five Hundred and Twelve Only) for the work for providing supply of electricity to the Ice Plant, under Electrical Section Pattambi, in 10 monthly installments, with applicable interest, as a special case.

Orders are issued accordingly.
