ABSTRACT

Construction of 110kV Substation at Vengara in Malappuram District– purchase of land by negotiation through DLPC- sanctioned- orders issued.

ORDER

The Administrative Sanction was accorded as per B.O. read as 1st above for the construction of 110kV Substation at Vengara in Malappuram District for an estimate amounting to Rs. 24 Crore. In the estimate an amount of Rs. 300 Lakhs was provided for the purchase of land.

The Chief Engineer, Transmission North as per letter read as 2nd above has requested sanction for the negotiated purchase of 115.60 cents of land in Re survey Nos. (86/6-4-4, 86/6-4-8, 86/6-4-6, 86/6-4-1, 86/6-4-5 & 86/6-4-9) of Oorakam Village, Tirurangadi Taluk, Malappuram District belonging to 6 land owners for the construction of 110kV Substation at Vengara. The documents pertaining to the proposed land were submitted to the standing counsel of KSEBL at Tirur for obtaining the legal opinion. The advocate opines that the land documents are valid and suitable for purchase.

The matter was placed before the Full Time Directors as per note read as 3rd above. Having considered the matter in detail, the Full Time Directors in the meeting held on 30.05.2020,

Resolved to accord sanction for the purchase of 115.60 Cents of land in Re survey Nos. 86/6-4-4, 86/6-4-8, 86/6-4-6, 86/6-4-1, 86/6-4-5 & 86/6-4-9 of Oorakam Village, Tirurangadi Taluk, Malappuram District belonging to 6 land owners by negotiated purchase through the District Level Purchase Committee (DLPC) in connection with the construction of 110kV Substation at Vengara.
