## ABSTRACT

Construction of 66kV DC line in 110kV parameters from the existing 66kV Kaniyambatta-Sulthan Bathery line to the 66kV Substation under construction at Ambalavayal – Disposal of trees along the 22m RoW across the Cheengeri Tribal Farm-Land owned by ITDP - Disposal of trees by E-auction through M/s. MSTC Limited - sanctioned- orders issued.

### ORDER

The construction of 66 kV Substation in 110 kV Parameters at Ambalavayal is nearing completion. The Substation works have already been completed and the tower erection and line stringing for the 66 kV LILO line from Kaniyambetta- Sulthan Bathery line is progressing. The proposed line is passing through the Cheengeri Tribal Farm under ITDP for a stretch of 1.504km. For the successful completion of the project, around 782 trees standing in the RoW of the line are to be cut and removed. Tree cutting notice has been issued to the ITDP Project Officer, Kalpetta showing the details of the trees.

In this regard, sanction has been obtained from ITDP to cut the trees on the condition that KSEBL shall conduct the auction of the trees and the proceeds from the auction shall be remitted to the respective account head of the department. It is also requested to transport the reserve trees to the Kuppadi Timber Depot of the forest Department. The Social Forestry Department has completed the valuation of the trees (excluding reserved tree) and the total value is estimated at ₹ 42,63,873/- (Rupees Forty Two Lakh Sixty Three Thousand Eight Hundred and Seventy Three Only).

The Chief Engineer (Transmission North) as per the letter read 1<sup>st</sup> above has requested sanction for conducting auction for the disposal of trees in the RoW of above line and passing through Cheengeri farm of ITDP and for remitting the auctioned amount to the account head of Tribal Department. It is also suggested to conduct auction in standing for the disposal of the trees, as the same is expected to give more competitive rates. It is further suggested to use the E auction platform of M/s. MSTC, for ensuring transparency. The Chief Engineer (Transmission North) has also reported that about 95% of the works have been completed at an investment of nearly Rs. 12 Crore and for the

Resolved to accord sanction to conduct E-auction for the disposal of trees along the 22M RoW across the Cheengeri Tribal Farm in connection with the construction of 66kV Substation at Ambalavayal.

Further resolved to entrust the Chief Engineer (SCM) with the E-auction of the trees using the MSTC platform.
