ORDER

A Petition was received from Sri. Krishnan P. C. Puthenpuraackal(II), Malippara, in the Vidyuthi Adalath 2020, requesting service connection to his house constructed under the Life Mission Project, who belongs to BPL category. The Adalath committee, after verifying the documents, instructed the Assistant Engineer, Electrical Section, Keerampara to examine the petition and take urgent necessary action. Accordingly, the site was inspected and an estimate amounting to Rs. 93,000/- was prepared for constructing 242m LT single phase 2 wire line for giving service connection.

As per Board Order read (1) above, for effecting service connection to BPL households, free connection (WP with support posts/ post insertion plus a maximum of 200 m OH) shall be given to BPL households with a maximum of 1000 W connected load, till the end of the plan period 2018-22 or till the fund of Rs.50 Crores allotted for "continued electrification" in the plan fund for the period is exhausted, as long as there are no other specific schemes in place for granting electricity connections to BPL households free of cost.

Even though the above applicant comes under BPL category, the overhead line required for providing service connection exceeds the limit as per B.O. read (1) above.

Hence, the Deputy Chief Engineer, Electrical Circle, Perumbavoor, as per letter read (2) above, has forwarded the matter for necessary direction.

The matter was placed before the Full Time Directors as per note read as 3rd above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 07.05.2020, resolved to accord sanction to the Deputy Chief Engineer, Electrical Circle, Perumbavoor to execute the work of providing service connection to Sri. Krishnan P.C., Puthenpurackal (H), Malippara at an estimated cost of Rs.93,000/- using KSEBI's fund, considering it as a special case.

Orders are issued accordingly.
