## **ORDER**

The President, Mankada Agricultural & General Marketing Co-operative Society Ltd., Makkaraparamba as per petition read as 2<sup>nd</sup> above, requested for waiving interest in instalments sanctioned in the Adalath conducted in Malappuram District for remitting estimated cost for providing supply of electricity to the coconut processing unit which is going to be started at Makkaraparamba under Electrical Circle, Manjeri. The Administrative Sanction for the work for providing supply of electricity to the Society under Electrical Section Vythiri was accorded on 07.02.2020 for an amount of ₹14,88,501/- by the Executive Engineer, Electrical Division, Perinthalmanna.

In the Adalath, it was allowed to remit the estimate amount in 12 instalments with interest.

The matter was placed before the Full Time Directors as per note read as 3<sup>rd</sup> above.
