### ORDER

In view of the Lockdown declared in the whole State of Kerala in connection with the COVID-19 Pandemic, the due dates for payment of HT/EHT bills for the months of March and April 2020 were extended upto 03.05.2020 as per Board Order read (1) above.

As the Government has further extended the Lockdown to 17.05.2020, various consumers have requested to extend the due date for payment of the HT/EHT bills for the months of March and April 2020.

The matter was placed before Full Time Directors as per note read above.

Having examined the matter in detail in its meeting held on 07.05.2020, the Full Time Directors resolved to accord sanction to grant time extension from 03.05.2020 to 16.05.2020 to HT/EHT consumer for paying electricity bills without charges for belated payment considering the extension of Lockdown.
