Abstract

Waiver of meter fault penalty imposed for non-replacement of faulty meter by M/s. Government Engineering College Thiruvananthapuram (LCN 27/4119) - Sanctioned - Orders issued.

ORDER

The ToD Meter of M/s. Government Engineering College, Thiruvananthapuram became faulty due to the defect of 11 KV multi panel system with effect from 09.08.2019 and the matter was intimated to the consumer as per paper read 1st above. But unfortunately the consumer was failed to replace the meter till date and as per Tariff Order dated 08.07.2019 Part B, General condition for HT and EHT Tariff 4(d) meter fault penalty was charged 50% extra over the prevailing rates applicable to him for both demand and energy.

Now as per letter read 2nd above, the consumer requested to waive off the meter faulty penalty charged amounting ₹ 8,03,579/-. They remitted ₹ 15,24,200/- as the estimate amount for the work of replacing the defective meter on 28.10.2019 to the PWD Department. Since the consumer is a State Government institution, Kerala Public Work Department is the agency to do the work and there is no intention behind the delay. It is a non-profitable Government educational institution and the delay occurs only due to the Government Departmental procedure.

The matter was placed before the Full Time Directors as per paper read 3rd above. Having considered the matter, the Full Time Directors in its meeting held on 03.03.2020 resolved to accord sanction to waive the meter fault penalty of ₹ 8,03,579/- of M/s. Government Engineering College, Thiruvananthapuram (LCN 27/4119) considering the fact that the consumer is a Government institution and that there is only procedural delay.


