ABSTRACT

Construction of 8 km, 3x33 kV OH line with covered conductor for power evacuation from the Paivalikae solar park to the 110kV Sub Station, Kubanoor - Approval given for finalising the tender – Ratified- Orders issued.

ORDER

The revised Administrative and Technical sanction for an estimate amounting to ₹ 10.9 Crore was accorded as per order read as 1st above for the deposit work of power evacuation from the 50MW Solar park being developed by M/s. RPCKL at Paivalikae to the 110KV substation, Kubanoor under Transmission Circle, Kannur. The work includes supply, drawing, testing and commissioning of 8 km of 33kV covered conductor on specially designed A poles on turn key basis.

The Chief Engineer, Transmission North as per letter read as 2nd above has reported that the working estimate amounting to ₹ 10.5 Crore (inclusive of 18% GST) was sanctioned and the work was tendered. The tendered PAC including GST was ₹ 10,43,54,616/-. Two bidders participated in the tender and both of them were qualified. M/s Amrutha Associates, Ernakulam quoted 5.016% above PAC which was the lowest and after negotiations the firm reduced the rate to ₹ 10,40,88,370/- which was 0.255% below PAC.

The construction of solar park at Paivalikae is progressing fastly and is to be completed before August 2020. The power evacuation work is to be completed by the time the solar park is ready and citing the urgency in completing the power evacuation works, the Chief Engineer recommended to award the work to the lowest bidder, M/s Amrutha Associates, Ernakulam at the quoted rate of 0.255% below PAC and requested sanction for the same.

Having considered the recommendation of the Chief Engineer, Transmission North and in view of the urgency in completing the power evacuation facilities at the earliest, sanction was accorded as

per proceedings read as 3rd above to "Award the work of Manufacturing, supplying, drawing, testing and commissioning of 8km of 33kV Double circuit feeder with 33kV covered conductor (CCSX 329 sqmm ACSR conductor or equivalent) on specially designed A poles from the 50MW Solar park at Paivalikae to 110kV sub station, Kubanoor under transmission circle, Kannur and hand over to KSEBL on turn key basis" to the L1 bidder, M/s Amrutha associates, Ernakulam at their negotiated quoted amount of ₹ 10,40,88,370/- (Rupees Ten crore forty lakh eighty eight thousand three hundred and seventy only) including 18% GST which is 0.255% below PAC.

The matter was placed before the Full Time Directors as per note read as 4th above for ratification.

Having considered the above, the Full Time Directors, in the meeting held on 23.04.2020 RESOLVED to ratify the action of the Director(T,SO&S) in having issued sanction to the Chief Engineer, Transmission North to award the work of power evacuation from the 50MW Solar park at Paivalikae to 110kV sub station, Kubanoor on turn key basis to the L1 bidder, M/s Amrutha Associates, Ernakulam at their negotiated quoted amount of ₹ 10,40,88,370/- (Rupees Ten crore forty lakh eighty eight thousand three hundred and seventy only) including 18% GST which is 0.255% below PAC.

Orders are issued accordingly.
