ORDER

The SCADA/DMS project was sanctioned under Part - A of R-APDRP scheme in Thiruvananthapuram, Ernakulam & Kozhikode cities. M/s. Kalki Communication Technologies Ltd. Bangalore was appointed as SCADA-DMS Consultant (SDC) as per order read (2) above for the preparation of DPR, Bid document and program management of Implementation of the Project from concept to commissioning. The period of engagement of the original contract was up to 02-04-2014 and the contract amount was Rs.49.95 Lakhs.

The time line for completion of the SCADA/DMS project to the SCADA/DMS implementing agency (SIA) has been extended based on the sanction received by the PFC. The contract with M/s. Kalki Communication Technologies Ltd as SDC was also extended in line with the extension of time line for completion of the project. During the above period, the SDC is assisting KSEBL in reaching various milestones in line with the RFP.

The major activities remaining for which support of SDC for accomplishing the satisfactory closure of the project and thus conversion of Loan amount to Grant from PFC are Fine tuning requirements in the field, Finalization of as built DPR of the project with respect to the awaited TPIEA report, Project closure as per PFC etc. These activities are the final milestone - successful completion of all responsibilities and obligations under the contract" as per original LoA issued to

Considering the essentiality of the above service required from SDC which are under SDC. progress, delayed due to COVID- 19 pandemic, the Chief Engineer (IT,CR & CAPS) recommended as per note read 3 above to extend the contract with M/s. Kalki Communication Technologies Pvt. Ltd for a further period of three months from the date of expiry up to 30.06.2020 with the same terms and conditions of the existing contract.

Having considered the above, the FTD meeting held on 16.04.2020 resolved to accord sanction to extend the consultancy services of M/s. Kalki Communication Technologies Pvt. Ltd., Bangalore for SCADA DMS project for a further period of three months from May 2020 (excluding the lockdown period) for Rs.3,34,530/-(Rupees Three Lakhs Thirty Four Thousand Five Hundred and Thirty only) with the existing monthly rate of Rs.1,11,510/- (Rupees One Lakh Eleven Thousand Five Hundred and Ten only) including taxes, with the same terms and conditions of the existing contract, considering the seriousness of the threat posed by the pandemic Covid – 19.
