Proposal for changing existing tariff structure of Land line Connection under distribution wing of KSEBL - Sanctioned- orders issued -

The present tariff structure of landline connections in Distribution offices of KSEBL is sanctioned as per B.O read as 1st above. BBG Combo ULD 1199 is the present plan (with reduction of 16.5% on fixed monthly charge) for all landline connections under all distribution offices of KSEBL. As per this plan, unlimited data (4Mbps upto 20GB, beyond 2Mpbs) and unlimited free call facilities (any time to any network anywhere in India) are applicable with a monthly billing amount of Rs. 1001 + Tax per connection.

Later on 01.07.2019 BSNL has revised the above tariff to BB plan 1299 and revising the quantum of bandwidth and data usage as upto 10Mpbs till 22GB/day and beyond at 2Mpbs speed. The Deputy Chief Engineer, System Operation Circle, Tvpm has reported that the data facility in the present plan (22GB/day) is very exorbitant and on analyzing the pattern of usage in distribution offices it is seen that the usage is less than 2 GB/day.

On analyzing various plans offered by the BSNL, as per note read as 2nd above, the Deputy Chief Engineer, System Operation Circle, Tvpm has recommended BBG Combo ULD 399 Plan for Land line Connections under distribution wing of KSEBL instead of present plan (BBG combo ULD 1199).

The salient features of the proposed plan are detailed below.

Considering the financial benefit offered in the proposed plan of BSNL (BBG Combo ULD 399) the Director (Transmission,System Operation & Safety has suggested to approve the new proposal as it will be beneficial to KSEBL.

The matter was placed before the Full Time Directors as per note read as 3rd above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 16.04.2020,

Resolved to approve the new plan of BSNL, BBG Combo ULD 399 for land line connections of Distribution offices of KSEBL instead of existing BBG Combo ULD 1199.

Further resolved to authorize the Deputy Chief Engineer, System Operation Circle, Thiruvananthapuram to negotiate with BSNL to implement the Plan change with immediate effect in order to get the maximum benefit to KSEBL.

Orders are issued accordingly.
