ORDER

Purchase orders read as 4 above were placed with M/s.Traco Cable Company Limited and Kerala based 10 MSMEs for the supply of 39,659 km ACSR Rabbit and 9,740 km ACSR Raccoon Conductors with price variation in the ratio 55:45 respectively at the discovered rate as per last tender plus 10% Price preference on basic price in anticipation of Government Order and ratification of the Board to meet the urgent requirement of ACSR Conductors. The action has been ratified as per order read as (6) above.

Due to the delay in issuance of Government order, KSEBL as per order read as 5th above has accorded sanction to retain 10% bill amount excluding Freight Charges from the 95% supply bills of the suppliers, till releasing of Government orders, regarding decision on 10% price preference proposed by the Government and the exclusive purchase of ACSR Raccoon & Rabbit Conductors from MSMEs and M/s.Traco Cable Company Limited.

The Government as per order read as 7 above has accorded sanction to KSEBL to procure ACSR Conductors (up to 19 strands) from M/s.Traco Cable Company Limited and Kerala based MSMEs at the existing Purchase Order rate i.e., discovered rate as per last tender plus

10% Price preference, in the ratio 55:45, with IEEMA Price variation for two years, considering the variation in market rate.

The matter was placed before Full Time Directors as per note read as 8th above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 16/04/2020, resolved to accord sanction to direct the consignees to stop further recovery of 10% amount and to release 10% bill amount retained as per order dated 30/01/2020 from the 95% supply bills of M/s. Traco Cable Company Limited and Kerala based MSMEs.

It is further resolved to request the Government to reimburse the additional expenditure incurred by KSEBL due to the 10% Price Preference on basic price allowed as per Government Order dated 19/12/2018 & 07/03/2020 to M/s.Traco Cable Company Limited and Kerala based MSMEs for the supply of ACSR Raccoon, Rabbit and Weasel Conductors.

Orders are issued accordingly.
