#### **ORDER**

As per letter read as 1<sup>st</sup> above, the Chief Engineer (Distribution North), Kozhikode has reported that the Deputy Chief Engineer, Electrical Circle, Palakkad invited tenders for hiring vehicle (mini lorry below 5 T) for the use of TFRU, Palakkad. In response, two tenders were received. The lowest rate of ₹32.90/- per km was quoted by Sri. Abdulla P.K., Pookkattukunnath (H), Peroor (PO), Ottapalam, Palakkad. On negotiations, the lowest tenderer offered the rock bottom rate as ₹32.40/- per km. It is reported that there is only remote chance of getting better offer on re-tender. Further, the expenses towards maintenance charges such as fuel, oil, tyre etc. has been increased considerably.

In the circumstances, the Chief Engineer (Distribution North), Kozhikode has requested sanction for hiring a vehicle (mini lorry below 5 T) at the rate of ₹32.40/- per km offered by the lowest tenderer Sri. Abdulla P.K., Pookkattukunnath (H), Peroor (PO), Ottapalam, Palakkad for the use of TFRU, Palakkad.

The matter was placed before Full Time Directors as per note read as 2<sup>rd</sup> above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 20/03/2020, resolved to accord sanction for hiring a vehicle (Mini lorry below 5 T) for the use of TFRU, Palakkad under Electrical Circle, Palakkad at the negotiated rate of ₹32.40/- per km offered by the lowest tenderer Sri. Abdulla P.K., Pookkattukunnath (H), Peroor (PO), Ottapalam, Palakkad.
