ABSTRACT

Construction of 33kV Substation at Thumboor under Transmission Circle, Thrissur- purchase of land by negotiation through DLPC- Correction in the B.O - sanctioned- orders issued.

ORDER

Sanction was accorded as per B.O read as 1st above for the purchase of 55 Cents of land in survey no. 887/1 in Kottanellur Village, Mukundapuram Thaluk, Thrissur District, belonging to Sri M.R. Shaji, S/o. Raman, Manaparambil House, P.O. Thumboor in connection with the construction of 33kV Substation, Thumboor by negotiated purchase through the District Level Purchase Committee (DLPC).

The Executive Engineer, Transmission Division, Irinjalakuda as per letter read as 2nd above has reported that out of the proposed land of 54.98 cents (approx. 55 cents), the major area of 49.45 cents lies in survey No. 887/1 which was only mentioned in the B.O read as 1st above, but the balance small portion of 5.53 cents lies in the survey No. 888/2 of the same owner which was inadvertently omitted in the said B.O.

As the total land area of 55 cents lies in two survey numbers 887/1 & 888/2, the Director (T,SO&S) has suggested to include the Survey No. 888/2 in the above B.O. for avoiding confusion during purchase, however there is no change in the total area to be purchased and the financial commitments expected.

The matter was placed before the Full Time Directors as per note read as 3rd above. Having considered the matter in detail, the Full Time Directors in its meeting held on 20.03.2020,

Resolved to accord sanction for the purchase of 55 Cents of land (comprises of 49.45 cents in survey no. 887/1 & 5.53 cents in survey no. 888/2) in Kottanellur Village, Mukundapuram Thaluk, Thrissur District, belonging to Sri M.R. Shaji, S/o. Raman, Manaparambil House, P.O. Thumboor in connection with the construction of 33kV Substation, Thumboor by negotiated purchase through the District Level Purchase Committee (DLPC).

Further resolved to modify the B.O.(FTD) No. 132 /2020/D(T,SO&S)/T4/LA-Thumboor/2019-20) Dated: 02.03.2020 to the above extent.
