#### ORDER

As per the prevailing tariff regulations, sea food processing units in the LT category are entitled to get categorized under industrial tariff, whereas LT consumers engaged in the freezing and cold storage activity (only) are to be billed under LT VII A tariff. The position being so, the KSEBL finds it difficult to defend cases wherein accusations are made against certain consumers engaged in seafood industries who are found indulged in freezing/refrigeration activities only and no processing of seafood are going on in the premises. Often such consumers in the light of certificates issued by competent authorities like Factories & Boilers, Industries Department, Pollution Control Department etc succeeds in effectively rebutting the contentions to the contrary.

The Legal Adviser & Disciplinary Enquiry Officer as per note read 4 above has reported a similar case and recommended to comply with the order dated 12.02.2018 of the KSEAA in Appeal No. 314/2017 and submit the fact before the Hon'ble High Court of Kerala.

The Full Time Directors in its meeting held on 20.03.2020, having considered the matter in details further resolved to authorize the Deputy Chief Engineer (Commercial and Planning) to take up the matter with Kerala State Electricity Regulatory Commission for re-assessing the tariff applicable to such units since the dominant load of all seafood processing units is for refrigeration and that only minimal power is used for other activities.

Resolved to accord sanction to comply with the order dated 12.02.2018 of the Kerala State Electricity Appellate Authority in Appeal No.314/2017 and submit the said fact before the Hon'ble High Court of Kerala in WP(C) No.22086/2019.

Orders are issued accordingly.
