ORDER

Execution of the projects included in Phase I of the Transgrid project is progressing fast and many of the works are nearing completion. For the successful and timely completion of the project as scheduled, continuity in operations at field level is necessary. In this regard, the Chief Engineer, Transgrid has requested protection from General Transfer 2020 to the employees working in Transgrid project who are willing to continue in their offices. As per the Board Order read above, the employees posted to Transgrid project are exempted from transfer for a minimum period of three years or till completion of the project whichever is earlier.

The importance of the project is evident from the fact that the Government of Kerala has included the same in the list of flagship projects. It is worth mentioning that timely completion of the project is also critical to the energy security of the State. In view of the above, the Director (Transmission, System Operation & Safety) has suggested as per the note read as 2nd above to exempt the employees working under Transgrid project and who are willing to continue from the General Transfer 2020.

The matter was placed before the Full Time Directors as per note read 2nd above for decision. The Full Time Directors in its meeting held on 20.03.2020 has examined the matter in detail and

Resolved to exempt the employees working in TransGrid Projects (as per the list annexed) and willing to continue in TransGrid project from General Transfer 2020 for ensuring successful and timely completion of the project.
