## ABSTRACT

Construction of 110kV Cherai-Njarakkal DC line for providing reliable power supply in Vyppin constituency–Floating tender on turn key basis-sanction accorded - orders issued.

## ORDER

KSEBL as per BO read as 1 above accorded administrative sanction for an estimate amounting to Rs. 24 cr. for the following works in connection with the development of electrical network for providing reliable power supply in Vyppin Constituency:-

- i) Construction of 110kV Cherai- Njarakkal DC line
- ii)Upgradation of 66kV Njarakkal Sub station to 110 kV

The Chief Engineer, Transmission South as per note read as 2<sup>nd</sup> above has requested sanction for executing the construction work of 110kV Cherai- Njarakkal DC line on tun key basis citing the fact that the proposed 13 km long Cherai- Njarakkal line route is partly through densely inhabited urban areas, paddy fields and backwaters. The monsoon and daily tide timings would restrict the actual working time. The disruptions in power supply during conductor stringing are to be minimised so that inconvenience to public is minimum thus necessitating adherence to a strict time schedule for executing the work. The Chief Engineer has also reported that as per the finalised tower schedule, special type of towers which are not in the regular line of procurement of SCM are required for the project and delay in procurement of materials would prolong the project.

The matter was placed before the Full Time Directors as per note read as 3<sup>rd</sup> above.

Having considered the matter in detail, the Full Time Directors in its meeting held on 20.3.2020 RESOLVED to accord sanction to float the tender for construction of 110kV Cherai- Njarakkal DC line on turn key basis for ensuring completion of work as per the expected schedule.

Orders are issued accordingly.
