Enhancing monthly ceiling limit of hired vehicles attached to Meter Testing Sub Division, Kozhenchery and Kundara - Sanctioned - Orders issued.

<u>ORDER</u>

The Chief Engineer (Transmission System Operation) as per letter read as 1st above has requested sanction to enhance the monthly celing limit of hired vehicle attached to the Meter Testing Sub Division (MTSD), Kozhenchery and Kundara from the existing limit of 2000km to 2500km.

The MTSD Kozhenchery is attending the solar installation testing request of 12 Electrical Divisions under Pathanamthitta, Kottayam and Idukki districts and routine meter testing works of 72 Nos. of Substations (including Alappuzha District). The above works are to be completed within a year which means 6 Substations to be covered in each month.

The MTSD Kundara is attending the solar installation testing of 9 Electrical Divisions under Kollam and Alappuzha Districts and in addition to this, routine meter testing work for 69 nos. substations have to be completed within a year, which means 6 substations have to be covered in each month. Due to enabling DLMS works of IT Wing and the addition of solar work on Electrical Division Alappuzha and Cherthala, the routine maintenance of Substations were pending to limit the km run of the vehicle up to 2000km.

The detailed note elaborating the need for enhancing monthly ceiling limit of hired vehicles attached to Meter Testing Sub Division, Kozhenchery and Kundara was placed before the Full Time Directors as per note read as 2nd above. Having considered the matter in detail, the Full Time Directors in its meeting held on 20.03.2020,

Resolved to accord sanction to enhance the monthly ceiling limit of conveyance of hired vehicle attached to Meter Testing Sub Division Kozhencherry and Kundara from existing limit of 2000km to 2500km.
