Manufacture and supply of 8m and 9m PSC poles to various Electrical Circles in Northern Region, North Malabar Region, Central Region & Southern Region – Invitation of fresh tenders – Administrative Sanction - Accorded– Orders issued.

ORDER

As per Board Orders read (1) and (2) above, tenders were invited and Purchase Orders were placed with various firms for the manufacture and supply of 8m and 9m PSC poles for two years (2018-19 & 2019-20).

The supply period of the existing contract in Northern and North-Malabar Regions is upto 31/05/2020 from private yards and upto 30/04/2020 from Departmental yards. Supply period of M/s.Gautam Cement Works in Southern and Central Regions is from 01/07/2018 to 30/06/2020 and with other suppliers is from 01/08/2018 to 31/07/2020. The total ordered quantity of 8m and 9m PSC poles in all the Electrical Circles has almost been completely supplied. Additional Purchase Orders were placed with various suppliers (L2 bidders) in all Regions for meeting additional requirements including DDUGJY/IPDS works and for natural calamity restoration works in 2018 and 2019.

PSC poles are to be arranged through fresh tenders for the next two years for the 25 Electrical Circles in Northern Region, North Malabar Region, Southern Region and Central Region. It is proposed to invite new tender for the manufacture and supply of 8m and 9m PSC

poles to the Electrical Circle, Kottayam, along with the tender for other Electrical Circles in Southern and Central Regions.

The Chief Engineers (Distribution North), (Distribution North Malabar), (Distribution South) and (Distribution Central), have forwarded the requirement of 8m and 9m PSC poles for the next two years from 6/2020 to 5/2022 in Northern and North Malabar Regions and from 7/2020 to 6/2022 in Southern and Central Region for the 25 Electrical Circles respectively as detailed below:

Total requirement for four regions 8m-5,91,700 Nos. and 9m-2,79,600 Nos.

Sanction was accorded as per BO read 3 above, to invite next tender for the supply of 8m PSC poles with working load of 200 kg, as per REC specifications and with reintroduction of earthing wire in 9m PSC poles. The matter was placed before the Board of Directors meeting held on 07/11/2019 (vide Agenda 33-11/2019) for according sanction to invite fresh tenders for the manufacture and supply of 8m and 9m PSC poles with minimum requirement of 5,89,800 Nos. of 8m and 2,83,050 Nos. of 9m PSC poles for the next two years (from private yards and from two departmental yards at Mangattuparamba and Mananthavady) in all the 25 Electrical Circles and for according Administrative Sanction for an amount of Rs.325.20 Crore (Rupees Three Hundred and Twenty Five Crore and Twenty Lakh only) (including GST). But the matter was deferred in the Director Board of meeting held on 07/11/2019.

Meanwhile the Full Time Directors has as per BO read 5 above, resolved to keep in abeyance the decision communicated vide B>O read 3 above, to invite next tender for the supply of 8m PSC poles with working load of 200 Kg as per REC specifications 15/1979 and for reintroduction of earthing wire in 9m PSC poles.

As such the financial commitment is worked out considering the existing design specifications of 8m and 9m PSC poles without implementing the decisions as per BO read 3 above.

The financial commitment in respect of each region is worked out considering the cost of 8m PSC poles as Rs.2700/- (including GST @ 18%) and that of 9m poles as Rs.4100/- (including GST@18%) as detailed below.

The quantity of PSC poles proposed to be tendered (Requirement taken for the period from 01/06/2020 to 31/05/2022 in Northern and North Malabar Regions and from 01/07/2020 to 30/06/2022 in Southern and Central Regions).

Total financial commitment comes to approx. **Rs.275 Crore** (Rupees Two Hundred Seventy Five Crore only) (including GST).

Also the Full Time Directors meeting held on 13/02/2020 in respect of (Agenda Item No.45/2/20) read 7 above resolved to place the following matter before the Board of Directors of KSEBL for approval.

1) Sanction to invite tenders for the manufacture and supply of 8m and 9m PSC poles with minimum requirement of 5,91,700 Nos. of 8m and 2,79,600 Nos. of 9m PSC poles for next two years (from private yards and from two departmental yards at Mangattuparamba and Mananthavady) in all the 25 Electrical Circles in Southern Region, Central Region, Northern Region and North Malabar Regions with existing design specifications of 8m and 9m PSC poles.

2) Administrative Sanction for an amount of Rs.275 Crore (Rupees Two Hundred and Seventy Five Crore only) (including GST) for the purchase of 5,91,700 Nos. of 8m and 2,79,600 Nos. of 9m PSC poles in all the 25 Electrical Circles in Southern Region, Central Region, Northern Region and North Malabar Regions for requirement of next two years with existing design specifications of 8m and 9m PSC poles.

The matter was placed before the Board of Directors as per note read as 5th above,

Having examined the matter in detail, the Board of Directors in its meeting held on 04/03/2020 resolved to accord Administrative Sanction for an amount of Rs.275 Crore (Rupees Two Hundred and Seventy Five Crore only) (including GST) for the purchase of 5,91,700 Nos. of 8m and 2,79,600 Nos. of 9m PSC Poles in all the 25 Electrical Circles in Southern Region, Central Region, Northern Region and North Malabar Region for requirement of the next two years.

Resolved further to accord sanction to invite tenders for the manufacture and supply of 8m and 9m PSC Poles with minimum requirement of 5,91,700 Nos. of 8m and 2,79,600 Nos. of 9m PSC Poles for the next two years (from private yards and from two departmental yards

at Mangattuparamba and Mananthavady) as per the requirement in all the 25 Electrical Circles in Southern Region, Central Region, Northern Region and North Malabar Region.

Orders are issued accordingly.


