ORDER

The Chairman, Quilon Co-operative Spinning Mills Ltd, Chathannoor as per letter read as 1st above has informed that they are in the process of modernizing the entire spinning mill under NCDC assistance with the latest high technology machineries and their mill was temporarily shut down from 27.09.2018 for commissioning of new machineries. The machineries costing ₹968.76 Lakh are kept under packed condition in the Godown. Currently the HT connection was disconnected for non-remittance of power charges in the absence of operational cash inflow. They requested to provide an LT connection to provide safety to the machineries and lightening arrangement for the Security staff till the re-instatement of HT connection.

The Special Officer (Revenue) as per note read as 2nd above has reported that an amount of ₹2,21,49,152/- is outstanding as arrears (Principal) for the period from 10/2009 to 01/2020 against the HT Service Connection (LCN-18/336) and Security Deposit available is ₹49,99,906/- only. The service connection was disconnected on 05.02.2020.

The matter was placed before the Chairman & Managing Director for a decision as per note read as 3rd above and the Chairman & Managing Director ordered to place the matter before the Full Time Directors. The matter was placed before the Full Time Directors as per

Having examined the matter in detail, the Full Time Directors in its meeting held on 20.03.2020 resolved to accord sanction to consider the request of the Chairman, Quilon Co-operative Spinning Mills Ltd. under Electrical Section, Chathanoor to effect temporary LT service connection to the premises of Quilon Co-operative Spinning Mills Ltd. Chathanoor having outstanding arrears of ₹2,21,49,152/- (Principal) against the disconnected HT service connection, considering the very poor financial condition of the Mill and also to avoid destruction of the machinery since the mill is under the process of revival.

Orders are issued accordingly.


