## ORDER

The Letter of Award read as 1<sup>st</sup> above was issued to M/s Alectrona Energy Pvt.Ltd, Chennai amounting to Rs 5,82,00000/- (Rupees Five Crore and Eighty two lakhs only) for the work of installation and commissioning of 1MW Grid tied solar PV power project at 220kv substation, Mylatty. An agreement read as 2<sup>nd</sup> above was executed with the contractor on 1.3.2018. The site was handed over to the contractor on 14.8.2018. As per the agreement conditions, the date of commencement of work under the contract was 15 days from the date of agreement or the date of handing over of the site whichever is later. The contractor was granted a time extension for a period of 3 months from 1.6.2019 to 31.8.2019. Till now they have not started the work. As per their request, a Dispute Resolution Committee (DRC) was formed and in the meeting held on 4.2.2020 it was decided to grant a time extension for a period of 4 months. Accordingly, the matter was placed before the Full Time Directors (FTD).

Having considered the above matters in detail, the Full Time Directors in its meeting held on 20.3.2020 resolved to accord sanction for granting a time

extension to M/s Alectrona Energy Pvt Ltd ,Chennai for a period of 4 months without any financial obligations to KSEBL.

Orders are issued accordingly.
