ABSTRACT

TransGrid 2.0 – GIS Package#2- Construction of 400 kV GIS Substation, Kottayam – Awarding of the work - Sanction accorded - orders issued.

ORDER

Administrative Sanction was accorded as per BO read 1 above for the construction of 400 kV GIS Substation and associated works at Kottayam for an amount of Rs 285 crore. Accordingly, the Chief Engineer (TransGrid) invited financial bids from bidders pre-qualified through EoI for Substations with the PAC of Rs 162,43,44,718/- excluding GST. Out of the 10 bidders who were qualified as per the EoI of Substations, only 6 bidders submitted the financial bids and all of them fulfilled the technical requirements.

In the E tender, M/s.GE T&D India Ltd. became the lowest bidder at their quoted rate of Rs. 117,71,39,354/-. After e-RA, M/s Toshiba T&D Systems India Ltd became the L1 bidder with the quoted amount of Rs. 111,21,39,354/- which is 31.53% below the tendered PAC of Rs 162,43,44,718/-. Later, negotiation was conducted with the L1 bidder by constituting a high level committee as suggested by the BE & GR committee and accordingly, the quoted rate for spares and special tools was reduced by 18.23% by the bidder, bringing down the total quoted amount to Rs 111,00,19,676/- which is 31.66 % below the tendered PAC.

Based on the recommendation of the Chief Engineer (TransGrid) and the BE &GR Committee, the Director (Transmission, System Operation & Safety) recommended to award the work to M/s Toshiba T&D Systems India Ltd, the L1 bidder. The matter was placed before the Board of Directors meeting held on 04.03.2020 for consideration.

Having considered the matter in detail, the Board of Directors,

RESOLVED TO accord sanction for awarding the work of construction of 400 kV GIS substation at Kottayam to M/s Toshiba T&D Systems Pvt. Ltd, at their quoted amount of **Rs 111,00,19,676/-(Rupees One hundred and eleven crore Nineteen thousand Six hundred and seventy six only)** plus GST Extra, which is 31.66 % below the tendered PAC of Rs. 162,43,44,718/-.
