### ABSTRACT

TransGrid 2.0 – Sabari Lines Package and Thrissivaperur line strengthening (Phase II) package – Awarding of the work - Sanction accorded - orders issued.

### ORDER

Administrative Sanction was accorded for the Sabari lines Package which includes the construction of 220/110 kV MCMV lines to the proposed 220 kV Substations at Pathanamthitta and Kakkad for an amount of Rs 147.5 Crores as per B.O read 1 above and Thrissivaperur line strengthening Package-II involving the construction of 220/110 kV MCMV line to proposed 220 kV Substation, Vengallur for an amount of Rs. 116.83 Crores as per B.O read 2 above. Subsequently the Technical Sanction was issued for both the packages.

Accordingly, Chief Engineer (TransGrid) invited e-tenders followed by Reverse Auction through MSTC platform by clubbing the two packages together with a declared PAC of Rs. 203,21,81,034/- plus GST extra. Five bidders submitted their bids and all the bidders except one, fulfilled the pre qualification criteria. In the E tender, M/s R.S Infra Projects became the L1, with quoted amount of Rs 275,82,71,069/-. After e-RA, M/s Sterlite Power Transmission Ltd became the L1 bidder with quoted amount of Rs 255,81,69,891/- which is 25.88% above the tendered PAC of Rs 203,21,81,034/-. The L1 bidder has quoted Rs 2,48,98,825/- for dismantled materials against the estimated cost of Rs 2,48,98,825/- for the same.

On Negotiation at Board level, M/s Sterlite Power Transmission Ltd offered a discount of Rs 30,00,000/-(Rs Thirty Lakhs Only) from their original offer. Thus, the reduced quoted amount after negotiation is Rs 255,51,69,891/- which is 25.73 % above the tendered PAC of

Rs 203,21,81,034/- and after deducting cost of dismantled material, the net contract value would be Rs. 253,02,71,066/-.

Based on the recommendation of CE (TransGrid) and the observations of the BE &GR Committee, the Director (T,SO &S) recommended to award the subject work to the L1 bidder, M/s Sterlite Power Transmission Ltd. The matter was placed before the Board of Directors as per note read as 5 above for consideration.

Having considered the matter in detail, the Board of Directors, in its 52<sup>nd</sup> meeting held on 4.3.2020,

**RESOLVED TO** accord sanction to award the work of Sabari Lines Package and Thrissivaperur Lines Strengthening package-II, to M/s Sterlite Power Transmission Ltd at their negotiated quoted amount of Rs 255,51,69,891/- (Rupees Two hundred and fifty five crore fifty one lakh sixty nine thousand eight hundred and ninety one only), plus applicable GST, which is 25.73% above the tendered PAC of Rs. 203,21,81,034/-.

**RESOLVED FURTHER TO** approve the quoted amount of Rs 2,48,98,825/- (Rupees Two crore forty Eight Lakh Ninety Eight Thousand Eight Hundred and Twenty five only) which is at par with the estimate for the dismantled materials, plus applicable GST.

Orders are issued accordingly.
