Supply of ACSR Raccoon and Rabbit Conductors – Purchase from Kerala Based MSMEs and M/s. Traco Cable Company - Sanctioned – Orders issued.

ORDER

As per Board Order read as 1st above, KSEBL decided to procure 9740 Km of ACSR Raccoon and balance quantity of 39659 Km of Rabbit from M/s.Traco Cable Company Ltd and Kerala based MSME's in the ratio 55:45 at the existing Purchase Order rate i.e., discovered rate as per last tender plus 10% price preference on basic price with IEEMA price variation for two years, subject to the condition that Purchase Order will be issued only after getting the Government Order, based on the Minutes of Meeting held on 03/07/2019, chaired by the Hon'ble Ministers for Electricity and Industries. Government Order in this regard is yet to be received.

The Director (Distribution, IT & HRM) as per note dated 19/11/2019 reported the urgency of Rabbit Conductors for the execution of PMU works and deposit works due to the shortage of ACSR Rabbit Conductors. The stock of ACSR Conductors are not sufficient for completing PMU/Deposit work.

In order to meet the urgent requirement for the completion of PMU/deposit works for the year 2019-20, the Chairman & Managing Director, KSEBL issued directions to the Chief Engineer (SCM) to issue purchase order with immediate effect in anticipation of ratification of the Board of Directors.

Accordingly the Chief Engineer (SCM) placed 11 Nos. of Purchase Orders with M/s.Traco Cable Company Ltd (PSU) and the Kerala based MSMEs (10 MSMEs) for the supply of 39,659 km Rabbit and 9,740 km Raccoon Conductor with a financial commitment of Rs.230,65,10,545/- (Rupees Two Hundred and Thirty Crore Sixty Five Lakh Ten Thousand Five

Hundred and Forty Five only) with price variation in the ratio 55:45 respectively at the discovered rate as per last tender plus 10% Price preference on basic price, as per Purchase Orders dated 23/11/2019. The action in having issued Purchase Orders in anticipation of Government Order has to be ratified by the Board of Directors.

The matter was placed before the 52nd meeting of Board of Directors held on 04/03/2020 vide agenda item No.14-03/2020 for ratification vide note read as 3rd above.

Having examined the matter in detail, the Board resolved to ratify the action of the Chief Engineer (SCM) in having issued the Purchase Orders (11 Nos.) with M/s.Traco Cable Company Ltd (PSU) and the Kerala based MSMEs (10 MSMEs) for the supply of 39,659 km Rabbit and 9,740 km Raccoon Conductors in the ratio 55:45 with a financial commitment of Rs.230,65,10,545/- (Rupees Two Hundred and Thirty Crore Sixty Five Lakh Ten Thousand Five Hundred and Forty Five only).

Resolved further that payment of 10% price preference over and above the discovered L1 basic rate shall be effected only after release of Government order in this regard as per the minutes of the meeting convened by the Hon'ble Minister for Power dated 03/07/2019.

Orders are issued accordingly.
