## ORDER

The Chief Engineer (SCM) as per note read 2 above put up the requirements of Single Phase and Three Phase Energy meters in respect of distribution works for the financial year 2020-21 and sought sanction for placing before the Director Board to obtain Administrative Sanction.

The requirement is based on the note read 1 above, wherein it was requested to procure 10 lakh nos. of Single Phase Energy Meters and 85,000 nos. of Three Phase Energy Meters, for distribution works for the financial year 2020-21. The quantities of Single Phase and Three Phase Energy meters purchased for general scheme works for the financial year 2019-20 and the quantities for which additional orders can be placed as sanctioned as per Board Order read 3 above are furnished below.
