ABSTRACT

Upgradation and Conversion of 20.46km 66kV Kainatty-Sulthanbathery SC line to 110kV DC line - Tender excess sanctioned - orders issued.

ORDER

KSEBL had accorded revised administrative sanction as per BO read as 1 above , for the 'Upgradation and Conversion of 20.46km 66kV Kainatty-Sulthanbathery SC line to 110kV DC line' at an estimated cost of Rs.19.15 Crore. The working estimate amounting to Rs. 5.30 Crore including GST for the work was sanctioned by the Chief Engineer (Transmission North).

This work was tendered on 21/03/2019 without disclosing the PAC wherein 4 bidders participated. The tender was cancelled because of the very high rate offered by the L1 bidder (39.1% above PAC). Then the work was retendered on 01/08/2019. This time 5 bidders participated in which M/s V Tech Engineers, the L1 bidder quoted 32.1% above PAC. Viewing the exorbitant quote, the Board of Directors meeting held on 07.11.2019, as per paper read 2 above directed to cancel the tender and to retender the work.

Accordingly, the work was retendered with a PAC of Rs.4,44,86,375/-(excluding GST) on 04/12/2019 and 5 bidders participated. Sri. C. A. Shoukkathali, Ernakulam offered the lowest price i.e., Rs.4,98,24,739.76/- excluding GST which is 12.00% above the PAC. When GST @ 18% is included the total contract value would become Rs. 5,87,93,192.92/-.

The subject work is essential for strengthening the transmission system of Waynad District. The upgradation work of 13km of 66kV Kaniyambetta-Kuthumunda line was completed and the line was commissioned on 14-05-2019. As the subject line is a tap line of the above, upgradation of the

same is inevitable. Hence, the Chief Engineer (Transmission North) has recommended for awarding the subject work to Sri. C.A. Shoukkathali, Ernakulam at his quoted rate of Rs. 5,87,93,192.92/-.

On further negotiation, the tenderer has reduced the rate by 0.25% of PAC i.e., the negotiated quoted rate is 11.75% above estimated PAC and the quoted amount including GST comes to Rs.5,86,61,958/- .

The matter was placed before the Full Time Directors for a decision. The FTD meeting held on 26-02-2020, examined the matter in detail and decided to place it before the Board of Directors.

Accordingly the matter was placed before the Board of Directors in the 52nd meeting held on 04.03.2020 vide Agenda No. 26-03/2020. After detailed discussion, the Board,

Resolved to accord sanction for awarding the work of "Upgradation and Conversion of 20.46 km 66kV Kainatty - Sulthanbathery SC line to 110kV DC line " to the LI bidder, Sri. C.A. Shoukkathali, Chullikkattu, Pinarmunda, Peringala P.O., Ernakulam at his negotiated quoted amount of Rs. 5,86,61,958/- (Rupees Five Crore, Eighty Six Lakh, Sixty One Thousand, Nine Hundred and Fifty Eight only) including GST, which is 11.75 % above the tendered PAC.

Orders are issued accordingly.
