ORDER

M/s. Rubtech Industries (HTB 7/4514) was a High Tension consumer which comes under the jurisdiction of the Deputy Chief Engineer, Electrical Circle, Perumbavoor. The firm was under disconnection since 19.02.2018 as it defaulted in the payment of current charges. Revenue Recovery action was initiated against the consumer on 01.07.2019 for an amount of ₹ 20,86,311/- which includes pending current charges from 01/2018 to 04/2018, transmission development charges and dismantling charges.

As per letter read 1st above, the Deputy Chief Engineer, Electrical Circle, Perumbavoor intimated that the consumer has submitted a request for participation in Adalath 2020. The grievance was regarding the demand raised consequent to dismantling of service connection.

Hence, in the Electricity Adalath, which was conducted on 25.01.2020 in Ernakulam District, it was directed to adjust the security deposit as requested by the consumer i.e., on the date on which the request for dismantling was submitted and to workout the interest portion on the basis of it (Adalath Order read as 2nd above).

Hence, the arrear statement is revised by adjusting the Bank Guarantee on the last day of the month in which the request for dismantling was submitted by the consumer and the same was placed before Full Time Directors.

Thus the arrear statement is revised as follows:-
