ORDER

A petition was received in Santhwanasparsham Adalath 2021, held on 18.02.2021, from Sri. P.M. Rasheed. Pullikudiyil H, Neriamangalam, a person belonging to BPL category, requesting for a new service connection to his Life Mission Project and to shift a line passing through his property under Electrical Section, Kothamangalam II, wherein direction was issued to the Executive Engineer, KSEBL, Kothamangalam to shift the electric post using Board's fund.

Prior to this. Sri. P.M. Rasheed had applied for a new service connection to his premises under Life Mission Project on 22.10.2020. The field officers, having inspected the site, reported that the service connection can be effected only after shifting of a 3 phase 4 wire line passing through his property, so as to maintain the statutory clearance. Accordingly, an estimate amounting to Rs.25,732/- was prepared and demand note was issued to the petitioner Sri. P.M. Rasheed. But due to financial crisis, the petitioner failed to make the payment.

The Deputy Chief Engineer, Electrical Circle Perumbavoor, as per the letter read as 2nd above, has informed that the case is understood to be of genuine in nature and may be consider favorably.

The matter was placed before the Full Time Directors as per the note read as 3rd above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 07.05.2021, resolved to accord sanction to the Deputy Chief Engineer, Electrical Circle, Perumbavoor to carry out the work of shifting of electric post and the line passing through the

property of Sri. P. M. Rasheed, Pullikudiyil H, Neriamagalam, using Board's fund, for constructing a house under Life Mission Project, considering his poor financial condition.

Orders are issued accordingly.
