ORDER

The Deputy Chief Engineer, Electrical Circle, Perumbavoor, as per letter read as 1st above, has reported that for effecting service connection to Smt. Lakshmikutty, Karukunnel, Kuzhoor, Airapuram, belonging to BPL category and included in the Life Mission Scheme of Mazhuvannoor Grama Panchayath under Electrical Section, Valayanchirangara, requires construction of 215 meters of single phase two wire line and 35 meter of WP wire. The estimate for the same amounts to Rs.84,464/-.

The proposed line is along the Kamratha-Koozhoor Kavu road and then passing through a pocket road having 3 meters width. So consent is essential from various property owners. Also, 2 or 3 house constructions are in progress in this area under the Life Mission Scheme.

As the length of the proposed line exceeds the sanctioned limit for BPL category, as per Board Order read as 2nd above, the Deputy Chief Engineer has requested direction/sanction for effecting service connection.

The matter was placed before the Full Time Directors as per note read as 3rd above

Having considered the matter in detail, the Full Time Directors in the meeting held on 30.04.2021 resolved to accord sanction to the Deputy Chief Engineer, Electrical Circle, Perumbavoor to execute the work of providing Service Connection to Smt.Lakshmikutty, Karunnel, Kuzhoor, Airapuram at the estimated cost of Rs. 84,464/- (Rupees Eighty Four Thousand

Four Hundred and Sixty Four Only) using Board's fund, considering that the case is for construction of a house under Life Mission Project for a BPL applicant.

Orders are issued accordingly.
