## **ORDER**

The Chief Engineer Distribution (Central), as per the letter read as 1<sup>st</sup> above, has reported that Sri. Abdul Aziz, Chakkuparabil House, Karupadanna, belonging to BPL category under Electrical Section, Vellangallur under Electrical Division, Irinjalakuda, has submitted an application for service connection to his newly constructed house located at an isolated area of Thekkumkara Village. The quantum of works involves construction of 254m single phase 2 wire OH line with one no. post insertion and one no. support pole for which an estimate of Rs.1,21,154/- has been prepared. The connected load of the new house is 840W.

Even though the above applicant comes under BPL category, the overhead line required for providing service connection exceeds the limit as per Board Order read as 2<sup>nd</sup> above.

Sri. Abdul Aziz is presently residing in a rented house with his divorced daughter who is working as a teacher for Saksharatha Mission. It is reported that electricity is inevitable for conducting on-line classes of Saksharatha mission. The new house was constructed through the Kerala Government Life Mission Project.

Considering the financial condition of the applicant, the Chief Engineer Distribution (Central), has requested a favorable action for effecting free service connection to Sri. Abdul Aziz using KSEBL fund, as a special case.

The matter was placed before the Full Time Directors as per the note read as 3rd above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 07.05.2021, resolved to accord sanction to the Deputy Chief Engineer, Electrical Circle, Irinjalakuda to execute the work of providing service connection to Sri. Abdul Aziz,

Chakkuparambil House. Karupadanna under Electrical Section. Vellangallur, at the estimated cost of Rs. 1,21,154/-/- (Rupees One Lakh Twenty One Thousand One Hundred and Fifty Four Only) using Board's fund, considering it as a special case.

Orders are issued accordingly.
