Shifting of unsafe electrical line at the expense of the Board - representations from Smt. Shijitha, Punnalath Veedu, Kalluvathukkal, under Electrical Section, Pallickal before the Chairman & Managing Director, KSEBL, and the Chief Safety Commissioner, KSEBL: -- Orders issued.

ORDER

Smt. Shijitha, Punnalath Veedu, Kalluvathukkal, submitted a representation read as 1 above, before the Chairman & Managing Director, KSEBL and the Chief Safety Commissioner, KSEBL, that the LT single phase line passing dangerously close to her house had snapped and an accident was averted just because she happened to be at home (where her elderly parents and small kids reside) at the time, to alert the KSEBL officials. Fearing for her family's safety, she requested that the line be shifted at the expense of KSEBL, since she belongs to a BPL family and cannot afford the estimated expense of ₹ 25,000/-.

The Safety Commissioner directed the Executive Engineer, Electrical Division, Attingal as per letter read 2 above, to take steps immediately and to report back.

The Executive Engineer, in his report to the Deputy Chief Engineer, Electrical Circle, Thiruvananthapuram, intimated that the Assistant Engineer, Electrical Section, Pallickal inspected the site immediately and prepared an estimate (amounting to ₹ 19,217/-) for shifting the said line using two additional posts and the petitioner having conveyed her inability to remit the amount, tried to do essential remedial works by shifting/lifting the line, but couldn't carry out the works owing to opposition from the complainant's neighbours.; the complainant was therefore asked to approach the revenue authorities and to get back with a solution.

The line clearance from the ground as reported by the Assistant Engineer is 4.5m and the horizontal clearance from the building is 1.5m. The statutory clearance is 4.6 m from the ground and 1.2 m horizontal clearance from the building.

The Chief Engineer requested to consider the matter and to accord sanction to carry out the work at the expense of the Board as recommended by the Executive Engineer, Electrical Division, Attingal.

The matter was placed before the Full Time Directors as per note read as 4th above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 17/11/2020, resolved to accord sanction to the Executive Engineer, Electrical Division, Attingal, to carry out the work of shifting of the dangerously placed LT single phase line adjacent to the house of Smt. Shijitha, Punnalath Veedu, Kalluvathukkal, under Electrical Section, Pallickal, at an estimated expense of ₹ 19,217/- using KSEBL fund, considering the safety aspects and the poor finances of the petitioner, as requested by the Chief Engineer, Distribution South, as a special case.

Orders are issued accordingly.
