ABSTRACT

Request for enhancement of connected load from M/s KE Agro Arpookkara, Kottayam (LCN 13/8258) under Electrical Section, Aymanam - sanctioned- -- Orders issued.

ORDER

KSEBL as per BO read as 1st above had accorded sanction to the Deputy Chief Engineer, Electrical Circle, Kottayam, for processing the application received from the HT consumer M/s KE Agro Products, Arpookkara, Kottayam (LCN 13/8258) under Electrical Section, Aymanam, with pending arrears under dispute (pending disposal before the Appellate authority), for enhancement of contract demand from 350kVA to 450kVA and connected load from 481.87hp + 10.5hp + 5.29kW + 5kVA + 245kVAR to 694.37hp + 24kVA + 14.6kW + 245kVAR.

Since there were two LT connections in the premises (for the same purpose) and directions had been issued (on 20/11/2020) to the consumer to merge these two connections with the HT connection and to get the mandatory energisation sanction and scheme approval from Electrical Inspectorate, the Deputy Chief Engineer, while processing the enhancement request, sought clarification on the merger of the LT connections with the HT connection, and the Deputy Chief Engineer was directed by the Director (Distribution & IT) to take necessary steps in accordance with the existing regulations and in consideration of safety aspects.

The Deputy Chief Engineer, as per letter read as 2nd above reported that the consumer has submitted application for merging the LT connections with the HT connection and for increasing the contract demand from 350kVA to 450kVA and connected load from 481.87hp+ 10.5hp + 5.29kW + 5kVA + 245kVAR to 1072.37hp + 34kVA + 30.7kW + 285kVAR , and

that on scrutiny it was understood that there was a short assessment arrear of ₹10,41,022/- against one of these LT connections and this arrear is under dispute, pending before the Hon. High Court.

The Deputy Chief Engineer requested directions on whether the new enhancement request (for increasing the contract demand from 350kVA to 450kVA and connected load from 481.87hp + 10.5hp + 5.29kW + 5kVA + 245kVAR to 1072.37hp + 34kVA + 30.7kW + 285kVAR) with request for merger of 2 LT connections (one of which has a pending disputed arrear of ₹10,41,022/-), with the HT connection (against which there is another pending arrear of ₹ 5,98,607/-), be processed.

The matter was placed before the Full Time Directors as per note read as 3rd above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 01/10/2021,

1. Resolved to accord sanction to the Deputy Chief Engineer, Electrical Circle, Kottayam for processing the applications received from the HT consumer M/s KE Agro Products, Arpookkara, Kottayam (LCN 13/8258) under Electrical Section, Aymanam, for increasing the contract demand of their HT connection from 350kVA to 450kVA and connected load from 481.87hp + 10.5hp + 5.29kW + 5kVA + 245kVAR to 1072.37hp + 34kVA + 30.7kW + 285kVAR and for merger of 2 LT connections existing in the same premises (with consumer numbers 1146290007596 and 1146294006391), with the HT connection, even though the LT connection with consumer No.1146294006391 has a pending disputed arrear of ₹10,41,022/-, (case pending before the Hon. High Court), and the HT connection has a disputed pending arrear of ₹ 5,98,607/-, (case pending before the Appellate Authority).
2. Further resolved to direct the Deputy Chief Engineer to ensure that an undertaking in stamp paper is obtained from the consumer agreeing to remit the arrears related to both the HT and LT connections, as and when the cases are finally settled.

Orders are issued accordingly.
