## ORDER

A Petition was received from Sri. Gayan T.S, Eloor, Aluva, in the Santhwanasparsham Adalath 2021 , for shifting of line passing through his property so as to enable him to construct a house in his plot. Thereupon, direction was issued to the Assistant Engineer, Electrical Section, Aluva to obtain necessary sanction from Board for shifting of the line, considering that the applicant belongs to BPL category.

Prior to this, the same request was received in the Adalath 2020 , from the subject petitioner wherein the Adalath decision was to undertake the work exempting 50% of the estimated amount (Rs.42,815/-). Hence, an amount of Rs.16,049/- (i.e. 50% after excluding SOC charge, Supervision Charge & GST) was served to the petitioner. But, he was not willing to bear this amount, instead he demanded to execute the work free of cost.

Thereafter, the matter was again brought before the Santhwanasparsam Adalath 2021 held on 16.02.2021 at UC College Aluva. Also, Sri. Gayan T.S. has submitted a petition dated 19.03.2021 before the Director (Distribution) requesting for a favorable decision in this matter.

Accordingly, the matter was placed before the Full Time Directors as per the note read as 2<sup>nd</sup> above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 23.04.2021 resolved to accord sanction to the Deputy Chief Engineer, Electrical Circle, Perumbavoor to carry out the work of shifting of Electric line passing through the property of

Sri. Gayan T.S., Eloor Aluva, using Board's fund, considering his poor financial condition subject to the following conditions.

- (i) The consumer must be coming under BPL category
- (ii) The sole purpose of its shifting is for the construction of a house

Orders are issued accordingly.
