

Abstract

PVS Hospital(20/7002)-Covid Care Centre- Service Connection reinstated– Action ratified – Sanction Accorded – Orders issued

ORDER

M/s. PVS Hospital, an HT consumer (20/7002) under Electrical Section Kaloor, was under disconnected status since 27.07.2019, owing to pending arrears. The Deputy Chief Engineer, Electrical Circle, Ernakulam, as per letter read 2 above, intimated that based on the proceedings of the incident Commander and Sub Divisional Magistrate, Fort Kochi, PVS Hospital was taken over by the District Administration, Kaloor for functioning as Covid Care Centre. KSEBL was directed to reconnect the electric supply to the building. Accordingly, after joint inspection by the Electrical Inspectorate, District Administration and KSEBL officials, the supply to the premises was reinstated through the metering panel of consumer no 20/7002 on 29.03.2020. As per letter dated 19.06.2020, the Tahsildar, Kanayannur, was asked to remit an amount of Rs.51,53,000/- towards the security deposit and an amount of Rs.1785/- towards other charges for service connection. In reply, Kanayannur Tahsildar, as per letter dated 13.07.2020, informed that the Government Order for exempting security deposit would be produced shortly.

The Tahsildar, as per letter dated 17.07.2020, was again asked to produce the Electrical Inspectorate approval, the document, if any, regarding exempting security deposit and the remittance details of other required fees. But no reply was received.

However, agreement was executed with the Tahsildar, Kanayannur on 21.10.2020 without remitting the security deposit.

The Special Officer (Revenue), as per letter read 3 above, has informed that the said consumer has a pending arrear of Rs. 1,71,85,282/- for realization. Also, an amount of Rs.29,34,000/- is available against the consumer towards Security Deposit.

The Deputy Chief Engineer, Electrical Circle, Ernakulam, as per letter read 2 above, has requested for ratification for his action in having reinstated the HT service connection to the above consumer before executing of the agreement and without realizing the security deposit and other charges, considering the extreme condition of Covid 19 pandemic and considering the Circular dated 19.05.2020, read as 1st above, wherein direction was issued to provide electric supply to the arrangements made for defencing Covid 19 Pandemic.

The matter was placed before the Full Time Directors as per note read as 4th above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 20.11.2020, resolved to ratify the action of the Deputy Chief Engineer, Electrical Circle, Ernakulam in having reinstated the HT service connection to M/s. PVS Hospital for functioning as Covid Care Centre, before executing of agreement and without realizing the Security Deposit and other charges considering Covid-19 pandemic.

Further resolved to direct Deputy Chief Engineer, Electrical Circle, Ernakulam to take up the matter of remitting the pending amount, with the Tahsildar (LA), Kanayannoor

Further, resolved that once the Covid Care Centre Status is withdrawn the consumer has to be disconnected after serving DC notice.

Orders are issued accordingly.
