Projects Electrical Design as Nodal Officer to finalize the modalities and other terms & conditions for taking up the assignment with M/s NHPC. A meeting was convened on 23.03.2023 with the officials of M/s NHPC and based on the meeting, M/s NHPC has been forwarded the draft MoU to be executed between M/s NHPC and KSEBL for the design vetting of KSEBL projects.The legal vetting on the draft MoU was obtained as per note read as 3rd above. As per the MoU furnished by M/s NHPC, KSEBL shall upon signing of this MoU, shall release a Retainership Fee of Rs 25,00,000/-(Rupees Twenty Five Lakhs Only) to NHPC for commencement of service. This fee shall be adjusted against the last invoice under this MoU and balance if any shall be refunded to KSEBL.

The matter was placed before the Full Time Directors as per the note read as 4th above.Having considered the matter in detail, the Full Time Directors in the meeting held on 05.05.2023

Resolved to accord sanction to the Director (Generation- Civil) for signing the MoU with M/s NHPC for design vetting and to act as the Nodal Officer of KSEBL for the work of design vetting.

Further Resolved to accord sanction to the Chief Engineer (Civil - Construction) South through ARU at Civil Circle, Kothamangalam for remitting a Retainership Fee of Rs. 25,00,000/- (Rupees Twenty Five Lakh Only) to NHPC for the commencement of service.
